# HUD SECRETARY'S *Award for Excellence in Historic Preservation*

Each year the National Trust for Historic Preservation celebrates the best of preservation by presenting National Preservation Awards to individuals, nonprofit organizations, public agencies, and corporations whose contributions demonstrate outstanding achievements in historic preservation. The National Trust and the U.S. Department of Housing and Urban Development (HUD) jointly recognize organizations and agencies for their success in advancing the goals of historic preservation while providing affordable housing and/or expanded economic opportunities for low- and moderate-income families and individuals. One recipient is chosen for the HUD Secretary's Award for Excellence in Historic Preservation.

## CRITERIA FOR AWARD

Nominated projects or activities will be judged for the success they have achieved in preserving, rehabilitating, restoring, and interpreting our architectural and cultural heritage. The evaluation criteria include the following:

1. What is the impact of the nominee's project on the community?
2. What are the quality and degree of difficulty of the nominee's project or efforts?
3. What is the degree to which the nominee's project is unusual or pioneering, or serves as an example to influence others?
4. Does the nominated project or activity provide for the adaptive use of historic structures and districts for affordable housing and/or economic development opportunities for low- and moderate-income residents?
5. Is the project or activity in an area that is part of a locally developed, overall community revitalization effort or part of a community revitalization plan?

Although HUD funding or other participation in nominated projects is not required, the nomination should clearly state what role, if any, HUD played in the nominated project or activity.

A jury of preservation professionals and HUD representatives is invited each year to review the nominations for the National Trust/HUD Secretary's Award for Excellence in Historic Preservation and recommend a winner. Although the composition of the jury changes each year, the National Trust and HUD strive to achieve balanced representation from the various professional preservation disciplines and geographic regions of the United States.

## NOMINATION REQUIREMENTS

*Submit all nomination material both in hard copy and electronically on a Windows-compatible CD. Material that was not created electronically should be scanned and copied onto the CD. Each nomination must include the following:*

- A completed nomination form.
- \$25 nomination fee. Please make check payable to the National Trust for Historic Preservation.
- A concise description (750 words or less) of the project, agency, individual, or organization that is being nominated.

The description should be organized into five sections, each of which addresses the evaluation criteria identified above. Include start and completion dates. All those who made a significant contribution to the success of the program or project nominated for an award may be listed as co-nominees. Please list co-nominees on the co-nomination form.

- Fifteen (15) jpeg digital images at a minimum resolution of 400 dpi. Most images should be in a horizontal format. Digital images must be on the same CD that includes all other nomination material.

All images must be labeled and include a credit line for publication. Images should be in focus with proper exposure. Project images should demonstrate before-and-after results, show interior site shots taken from a variety of angles, and include overall exterior shots. Significant architectural detail should be identified with closeup shots. Images should include people and activity around the site, including a shot of the project in the context of the greater community.

- Up to five supporting brochures or news clippings.
- Up to five letters of recommendation that demonstrate community support. A list of any awards received may also be included.

## ELIGIBILITY

- Any project, agency, individual, or organization involved in historic preservation is eligible to receive the National Trust/HUD Secretary's Award for Excellence in Historic Preservation.
- Nominated projects must have been completed within the past three years.
- Nominations submitted in previous years that were not selected to receive an award may be revised, expanded, and resubmitted.
- Nominations may be made without the knowledge of the nominee. Self-nominations will be accepted.
- Nominations for posthumous awards will not be accepted.
- National Trust advisors, staff, and trustees and HUD staff are not eligible for a HUD Award for individual achievement during the period of their active service and for three years thereafter. Properties owned by the National Trust for Historic Preservation will not be considered, nor will individuals or groups of individuals be considered for their work related to National Trust properties.

## NOMINATION PROCEDURES

Nominations must conform to the procedures outlined in this announcement to be considered for a National Trust/HUD Secretary's Award for Excellence in Historic Preservation.

All nomination material must be submitted in a pocket-style folder that contains hard copies and the CD with electronic copies of all material.

Complete submissions must be postmarked by the March 2, 2009, deadline to be considered.

Unless the nominator indicates otherwise on the nomination form, all nominations not selected to receive a HUD Secretary's Award will be considered in the judging for the National Trust's National Preservation Honor Awards.

The recipient of the National Trust/HUD Secretary's Award for Excellence in Historic Preservation will be notified no later than August 1, 2009. In the case of all other entrants, the nominator will be notified. Award announcements and

presentations will be made at a special ceremony during the National Preservation Conference on October 15, 2009. Winning nominations will become the property of the National Trust and will not be returned. Other nominations will be returned. Return packaging, address, and postage

or shipping account number must be included with each nomination. Every effort will be made to protect the submissions. The National Trust cannot be held responsible for any of the material submitted.
